No individual intimation will be furnished.

3. In the event of e-Filing intending bidder may download the tender document from the website by the help of Digital Signature Certificate.
4. Technical Bid and Financial Bid both will be submitted concurrently duly digitally signed in the Website [wbttenders.gov.in](http://wbttenders.gov.in).

The documents submitted by the bidders should be properly indexed during participation in e-tendering. However, during execution of formal agreement, the contractor have to purchase 3 (three) sets tender documents.

5. Eligibility criteria for participation of bidder: Bonafide outsider and resourceful contractors having experience to execute similar nature of work in any **Govt. Sector/ Semi- Govt. Sector or Govt.** undertaking department also fulfil the criteria mentioned as below:
  - i) **a)** Intending tenderers should produce credentials of similar nature of completed work of the minimum value of 40% (for 1<sup>st</sup> Call), 30% (for 2<sup>nd</sup> Call) & 20% (for 3<sup>rd</sup> Call) of the estimated amount put to tender during last 5 (five) years prior to the date of issue of the tender notice.

- iii) Neither prospective bidders nor any of constituent partner had been debarred to participate in tender by Zilla Parishad during the last 5 (Five) years prior to the date of this NIT. Such debar will be considered as disqualification towards eligibility. (A declaration in this respect has to be furnished by the prospective bidders as per prescribed format without which the Technical bid shall be treated non-responsive).
- iv) The prospective bidders should own/ Lease agreement of required plants and machineries of prescribed specifications as shown in format. Conclusive proof of ownership / Lease agreement must be submitted.
- v) A Bidder can participate in more than one work under this NIT, provided that the bid capacity permits and the bidder is capable to arrange and deploy separate set of required machineries.
- vi) No Mobilization Advance/ Secured Advance will be entertained.

6. Payment will be made according to the availability of fund.

7. Constructional Labour Welfare Cess @ 1 (one) % will be deducted from every bill of the agency. Royalty & all other Statutory Levy/Cess will have to be borne by the contractor & the rate should be quoted accordingly.
8. Adjustment of price (increase or decrease) shall not be applicable. The bidders shall quote their rate (percentage above/below/at par) accordingly considering that no escalation and/or price adjustment will be allowed by Zilla Parishad thereto under any circumstances.
9. Bids shall remain valid for a period not less than 120 days (One hundred Twenty) from the last date of submission of Financial Bid/Sealed Bid.
10. There shall be no provision of Arbitration. Hence Cl. 25 of 2911 (ii) is omitted.
11. The bidders are encouraged to visit and examine the work site and its surroundings to obtain necessary information that may be required before submission of Bid and entering into a contract for the work as mentioned in the Notice Inviting Tender at his own cost and risk. For any queries the bidders are requested to contact with the tender inviting authority during any working days.
12. The intending Bidders shall clearly understand that whatever may be the outcome of the present invitation of bids, no cost of bidding shall be reimbursable by Zilla Parishad in any situation. The Tender Committee reserves the right to reject any application for purchasing bid documents and to accept or reject any offer without assigning any reason whatsoever and is not liable to pay/reimbursement any cost that might have incurred by any bidder at the stage of bidding.
1. Prospective applicants are advised to note carefully the minimum qualification criteria as mentioned in "Instructions to Bidders" before bidding.
13. No CONDITIONAL/INCOMPLETE TENDER will be accepted under any circumstances.
14. Labour Co-operative Societies are not exempted from depositing earnest money for participating in tender.
15. During scrutiny, if it is come to the notice of the tender inviting authority that the credential or any other papers found incorrect/manufactured/fabricated, that tenderer will not be allowed to participate in the tender and that application will be out rightly rejected without any prejudice with forfeiture of earnest money forthwith.
