- 1. As directed, the **District Engineer** on behalf of **South 24 Parganas Zilla Parishad** invites e-tenders from the intending experienced bonafide eligible resourceful outsiders and working contractors/ agencies of this Parishad having experience in relevant nature and magnitude of the constructional work mentioned as noted in Annexure-I (Enclosed).
- 2. The accepting authority does not bind him-self to accept the lowest tenderer and reserves the right to reject any or all of tenders received, without assigning any reasons. The inviting authority further reserves the right of splitting up any contract and distributing the same to more than one tenderer.
 - a. <u>This is an e-procurement tender and also a two bid tender. First bid should contain document of earnest money & cost of tender paper deposit, technical documents (i.e. credential etc.) and second bid should contain the financial offer to be submitted online.</u>
- **3.** Contractors/ agencies are requested to observe the required credential of a single work order as a prime contractor. If any agency found submitted bid for the specific serial with below or lapse credential the tender will not be accepted.
- 4. If any agency found submitted bid for the specific serial with false credential, the tender will not be accepted and the action will be taken against him.
- 5. (i) Eligibility criteria for participation of bidder: Bonafide outsider and resourceful contractors having experience to execute similar nature of work in any Govt. Sector/ Semi- Govt. Sector or Govt. undertaking department also fulfill the criteria mentioned as Below:

a) Intending tenderers should produce credentials of similar nature of completed work of the minimum value of 40% (for 1st Call), 30% (for 2nd Call) & 20% (for 3rd Call) of the estimated amount put to tender during last 5 (five) years prior to the date of issue of the tender notice.

- 5. (ii) The intending tenderers should submit tenders within specified time along with scanned copies of a) Trade License upto date, b) Valid 15 digit Goods and Services Tax payer Identification Number (GSTIN) registration Certificate (bidder's name only), c) Professional Tax Challan upto date, d) Pan card, e) latest I.T. return, f) e-mail ID, g) credentials certificate of similar nature of job as noted in Annexure-I (Enclosed). Credentials as a sub-contractor will not be considered, failure to produce the certificates shall make the bid non- responsive.
- 6. The intending tenderers shall have to furnish original completion certificate along with the payment certificate if required of similar works of sufficient magnitude as and when that will be demanded by the tender inviting authority.
- 7. The tender notice and detailed schedule of works may be obtained from the website: <u>zps24pgs.wb.gov.in</u> & <u>wbtenders.gov.in</u>.
- Last date of tender online submission upto 2:00 PM on 20.05.25, deadline of submission of original documents such as Bid Security, Cost of Bid document and Affidavit upto 4:00 PM on 21.05.25 and opening the bid on or after 2.00PM on 22.05.25 by the Tender Committee..
- 9. .The Bidder should quote his/their rates in figures and words on the basis of percentage above, below or at par with the schedule of rates attached with the tender form through online.
- 10. If the rate offered by the successful bidder is seriously unbalanced in relation to the estimated cost of the work, the bidder may require to produce detailed cost analysis for any or all the items of the schedule attached. Under the sole discretion of the inviting authority, the bidder may also require to deposit an extra performance security to a level sufficient to protect against financial loss in the event of default it should be final, binding and conclusive on the bidder.
- 11. Cost of tender paper (as indicated in the corresponding column of the work in the annexed sheet) should be deposited in the Savings Bank Account No. 0675010126441 of PNB, Tollygunge Tram Depot Branch (IFSC Code: PUNB0067520 through RTGS./NEFT or Fund Transferred Process only in favour of Additional Executive Officer, South 24 Parganas Zilla Parishad from bidder's account only. Cash deposit or transfer from any other account will not be considered, if arise, the tender will not be accepted. Counter foil/ bank receipt should be uploaded on e-portal. BANK DRAFT/ PAY ORDER will not be accepted.

12. Necessary Earnest Money (as indicated in the corresponding column of the work in the annexed sheet) will be deposited by the bidder electronically: online –through his net banking enabled bank account, maintained at any bank or: offline – through any bank by generating NEFT/ RTGS challan from the e-tendering portal. Intending Bidder will get the Beneficiary details from e-tender portal with the help of Digital Signature Certificate and may transfer the EMD from their respective Bank as per the Beneficiary Name & Account No., Amount, Beneficiary Bank name (ICICI Bank) & IFSC Code and e-Proc Ref No.

Intending bidder who wants to transfer EMD through NEFT/RTGS must read the instruction of the Challan generated from E–Procurement site.

Bidders are also advised to submit EMD of their bid, at least 3 working days before the bid submission closing date as it requires time for processing of Payment of EMD.

(Three State Government Enterprises viz. "Mackintosh Burn Limited.", "Westinghouse Saxby Farmer Limited", and "Britannia Engineering Limited", are exempted from deposit of earnest money for participation in tender vide Order No. 430(3)-W(C)/1M-208/15 dated 31.08.2015 of the Joint Secretary, P.W. Department, Works Branch, Govt. of West Bengal subject to the condition that they will furnish Security Deposit, if selected in the tender.)

13. In the event of e–filling, intending bidder may download the tender documents from the website: <u>wbtenders.gov.in.</u> directly with the help of Digital Signature Certificate. Technical Bid and Financial Bid both will be submitted concurrently duly digitally signed in the <u>wbtenders.gov.in.</u>

The documents submitted by the bidders should be properly indexed & digitally signed.

- 14. Both Technical document and Financial Bid are to be submitted in technical (Statutory & Non– Statutory folder) and financial folder concurrently duly digitally signed in the website <u>wbtenders.gov.in</u>
- 15. In case, if there be any objection regarding non qualifying in technical bids the agency should lodged complaint (through e-mail: <u>admzp.south24pgs@gmail.com</u> and <u>desouth24pgs@gmail.com</u>. simultaneously) to the Tender Inviting Authority within **48 (forty eight) hours** from the date & time of publication of list of qualified agency and beyond that time schedule no objection will be entertained by the Tender Inviting Authority.
- 16. Successful tenderer/s must have to execute a formal deed in Zilla Parishad agreement form within **fifteen days** from the date of acceptance of the tender, failing which action will be taken as per rule.
- 17. Tenderer/s shall be bound to execute any excess and supplementary works as may be ordered by the Engineer-in-Charge at the rate of prevailing schedule of PWD/PW(R) D, Govt. of W.B. at the time of tender submission.
- 18. The time is the essence of contract.
- 19. All risks or lose or damage to public property and or personal injury or death which arise during and in consequence of the performance of the contract are the full responsibility of the contractor.
- 20. Successful tenderers should have to submit work propgramme accordingly after obtaining the work order within seven days effectively otherwise panel action will be taken by the Z.P. Authority.
- 21. Successful tenderers should be required to execute formal agreement in duplicate within seven days from the date of receipt of letter of acceptance failing which his tender will automatically stand rejected. Security deposit will be deducted from each progressive bill due from time to time on account of work done and supplies made under a contract in such manner that final security deposit comes to 10% (ten percent) of the value of work done or supplied with and will be refunded after completion of the defect liability period is over as per the recommendation of Asst. Engineer & Sub Asst. Engineer in Charge of said work from the date of final measurement. Necessary times will also be deducted from each bill as per prevailing norms. No interest will be paid on security deposit.
- 22. During scrutiny, if it comes to the notice to tender Inviting Authority that the credential or any other documents found incorrect/manufactured/ fabricated, that tenderers will be not allowed to participate in the tender and that application will be rightly rejected without any prejudice.
- 23. All tools and plants and implements required for the construction of the work, will have to be supplied by the contractor at his/ their own cost.

- 24. The applications of the bidder, who could not complete the works entrusted to them in past to the full satisfaction of this **Zilla Parishad**, will not be considered.
- 25. 1% Worker's Welfare Cess (vide P & R.D. Deptt. No. 5794 (21)-RID(RIDF)/1A-1/2006 dt. 9.10.2006) will be deducted from the bills.
- 26. Defect liability period is 1 (one) year.
- 27. Informatory Board will be affixed at site at his own cost.
- 28. The prospective Bidder shall have, in their full time engagement, experienced technical personnel, the minimum being one Electrical Engineering Diploma holder failing which the bid will be liable for rejection [Authenticated documents in respect of qualification and engagement (in Non- judicial Stamp paper of appropriate value, duly notarized) shall have to be furnished in Non statutory Documents for Technical Evaluation without which the Technical Bid shall be liable for rejection.].
- 29. The bidder/ contractor must have valid Electrical Contractors License along with Electrical Supervisor holding Supervisor competency of Competency granted by Licensing Board, West Bengal in the parts 1,2, 3,4,6,7A, 7B &11or equivalent National Supervisors' Certificate of Competency, under full time engagement. An Affidavit, made by the said Supervisor in non-judicial stamp paper of appropriate value ulynotarized, statingsuchfulltimeengagementduringcurrenttenureandengagement/ appointment letter issued by the bidder should be furnished without which the Technical Bid shall be treated non- responsive. [Self attested scanned documents in respect of above i.e. qualification, declaration (in Non-judicial Stamp paper of appropriate value, duly notarized) and engagement shall have to be furnished in Non statutory Documents for Technical Evaluation. without which the Technical Bid shall be liable for rejection.
- 30. Submission of Original Documents: The bidders are required to submit original documents such as Bid Security, Cost of Bid document and Affidavit etc.if required, regarding correctness of information furnished with bid document as per provisions of Clause 5 (ii) & 8 of NIT with District Engineer, South 24 Parganas Zilla Parishad, New Administrative Building (2nd Floor), 12 Biplabi Kanai Bhattacharyya Sarani, Kolkata- 700027, on a date as specified in the NIT, either by registered post or by hand in the box, kept in the office of the undersigned failing which the bids shall be declared as non- responsive.
