The inviting authority further reserves the right of splitting up any contract and distributing the same to more than one tenderer.
 - a. This is an e-procurement tender and also a two bid tender. First bid should contain document of earnest money & cost of tender paper deposit, technical documents (i.e. credential etc.) and second bid should contain the financial offer to be submitted online.
- 3. Contractors/ agencies are requested to observe the required credential of a single work order as a prime contractor. If any agency found submitted bid for the specific serial with below or lapse credential the tender will not be accepted.
- **4.** If any agency found submitted bid for the specific serial with false credential, the tender will not be accepted and the action will be taken against him.
- 5. (i) Eligibility criteria for participation of bidder: Bonafide outsider and resourceful contractors having experience to execute similar nature of work in any Govt. Sector/ Semi- Govt. Sector or Govt. undertaking department also fulfill the criteria mentioned as Below:
 - **a)** Intending tenderers should produce credentials of similar nature of completed work of the minimum value of 40% (for 1st Call), 30% (for 2nd Call) & 20% (for 3rd Call) of the estimated amount put to tender during last 5 (five) years prior to the date of issue of the tender notice.
